The joint members of this account, if any, hereby agree with each other and with Pasadena Federal Credit Union that all sums now paid in on shares or heretofore or hereafter paid in on shares by and or all of said joint members to their credit as such joint members to their credit as such joint members with all accumulations thereon are and shall be owned by them jointly with the survivor or survivors shall be valid and discharge Pasadena Federal Credit Union from any liability for such payment.

Any or all of said joint members may pledge any or all of the shares in this account as collateral security to a loan or loans.

The right or authority of Pasadena Federal Credit Union under this agreement shall not be changed or terminated by said members, or any of them except by written notice to Pasadena Federal Credit Union which shall not affect transactions theretofore made. Shares are not transferable except on the books of the credit union.

I/we hereby make application membership in Pasadena Federal Credit Union. I/we hereby agree to be bound by the charter, bylaws, policies, and share account agreement of the credit union and any amendments thereto.
