## Diamond Member Referral Campaign\*

### Official Rules and Regulations

1. Pasadena Federal Credit Union (PFCU) members in good standing may refer an **UNLIMITED** number of qualified individuals who are not currently members of PFCU who meet our eligibility requirements (see account disclosures) and who open an account or apply for a loan with PFCU.
2. Each referral will result in one entry into our drawings. The new member who has been referred and successfully opens an account and/or applies for a loan also receives an entry.
3. Entrants must submit a referral form. On the form they may indicate if either the referring or referred member wishes to refrain from entering the contest. If they do not check off the box indicating that they opt out of participating, they will be entered, but an individual may decline a prize if they are notified that they are the winner.
4. Drawings will be held in the Pasadena FCU office and will consist of:
  - a. Quarterly drawings for **\$75 DEPOSIT INTO MEMBER ACCOUNT** on the first business day of April, July, and October, 2010, and January 3, 2011.
  - b. Grand Prize Drawing of a **\$750 DEPOSIT INTO MEMBER ACCOUNT** on January 3, 2011.
5. Winning entries in the quarterly drawings will be held for resubmission into the Grand Prize Drawing.
6. Entries remain eligible for prizes throughout the promotion, so the earlier a person enters, the more chances he or she has to win.
7. Actual odds of winning depend on number of entries.
8. No purchase necessary to enter. Members who do not refer a new member or are not referred by a member may submit a completed entry form.
9. Winner need not be present to claim prize.
10. Winners will be notified by phone and/or e-mail.
11. By accepting a prize, winner agrees that his/her name may be published by PFCU for promotional purposes. No additional compensation will be paid for publication of their name.
12. PFCU employees, volunteers and their families are not eligible to participate.
13. Must be 18 to be eligible for the drawings.
